Following the Executive Members Meet and the General Meet on 11th and 13th June, 2026, respectively, below are the revised rates that have been finalized to address the rising costs in petroleum products and other associated vehicle related articles.

Terms and Conditions of Vehicle Operations or SOP:

1. The above rates are applicable from 01st Sep 2026 onwards till further notice.
2. Driver duty will be predefined, and No duty hours after 8:00 PM or as directed by the itinerary. Exceeding at Rs.500/hr. Vehicles are strictly on the basis of itinerary / route declaration and not at disposal or roaming around on own.
3. Holding the vehicle, deviating the route and utilizing the vehicle on other purposes would attract price change.
4. GST will be applicable on the above pricing as per service providers.
5. The above rates are on basis of the current diesel rates, any hike in the diesel rates above Rs.110 / Liter or at the time of travel would be changed with revised fuel prices.
6. Toll and Parking included in the above pricing, repeat visit to particular spots/places would attract additional charges.
7. Entry Fee to Tourist Spots are not included in the above pricing.
8. Airport Parking Charges are included for One time pickup from One Airport Only (T1/T2/Shillong). Multiple Pickups from two or three different airports would be payable extra as per the airport parking charges and travel required.
9. **Payment Terms:** Payment of 30% at the time of booking and rest 70% on arrival and at the time of Pick Up.
10. Maximum Passengers allowed as per the declared vehicle seating capacity by the operators, change in guest count would fluctuate the price.
11. Expenses caused by factors beyond our control, for e.g. rail / flight delay, road block, natural calamities, vehicle malfunction, political disturbances, tourist spot closure etc are not included.
12. All Personal Travel Expenses not related to vehicle tourists' transports are not included.
13. In case of vehicle breakdown, the operator will have the morale responsibility to provide a substitute vehicle without any additional cost (subject to availability).
14. AC: Air-Condition of the vehicle will not be applicable on hills and also on standing vehicle.
15. Validation of all documents of the vehicle (like insurance, fitness, road tax, permit, PUC etc) are mandatory to operate and carry tourists safely across all states.
16. Vehicles without commercial number plates or personal vehicles with white number plates are not allowed to operate to carry tourist across north east.
17. Smoking and Drinking is not permissible inside the vehicle.
18. Night Journey is not advisable across the hills for tourist and driver safety. Kindly book your flight/train accordingly.
19. Additional charges would be applicable to travel to few spots wherein mid night travel is required to witness sunrise like Nongjrong or in cases wherein the hills are too stiff to climb on mutual agreement as per itinerary (For e.g.: Nongjrong/Mandala Top/Chakzam Bridge/Mago/Zemithang/Gorichen etc)
20. Request to respect the environment by keeping public areas and the vehicle litter-free, and using designated toilets; please note that littering or urinating in public spaces is strictly prohibited and may result in fines of up to Rs. 5,000 by Concerned Authorities. Respect mother nature.
21. Tourist may and have to take spot guides where and when required for remote location like, Wari chora, Baghmara, Shiju, West Khasi Hills, Double Decker Trek, Sacred Forests, Wei Sawdong etc and request to maintain the integrity of the places.
22. Owner / Operator reserves all the right to discontinue or cancel their services in case of disagreement / dispute. All disputes will be handled at Guwahati jurisdiction only.
